Scenic Bluffs Community Health Centers are excited to announce the upcoming renovation to their location in Cashton, Wisconsin. The project will add over 4,000 square feet to the Cashton facility allowing for the re-design of exam rooms, offices and a new training/conference room facility.

The first phase of the project will include an addition of a Conference/Training Room and Medical offices. The new Conference/Training room will be designed to facilitate more offerings of public classes like CPR, First Aid, and health education. The large meeting room can accommodate up to 70 people, but can also be divided into 3 small meeting rooms as needed.

Ground breaking for construction at the Cashton location is slated for early June, with an estimated date of completion for mid-October 2015. The design and construction will be done by Keller Construction, a Wisconsin based design-build firm that specializes in smaller healthcare centers.

During the construction, Scenic Bluffs will continue serving patients in the Cashton location and will also be utilizing additional locations, including the Norwalk location and the Scenic Bluffs Administration building in Cashton. These locations will allow Scenic Bluffs to continue to offer consistent services to patients with minimal disruption during the renovation.
